The Ph.D. dissertation examines the possible impact of the shadow banking system on inflation and effectiveness of the monetary policy in Egypt using a quarterly data during the period 2008-2014. Based on the five shadow banking functions classified in the Financial Stability Board report of the International Monetary Fund in 2015, the study contributes to the existent literature by introducing a new composite measure of activities of the shadow banking system in Egypt. The study finds a positive and statistically significant impact of activities of the shadow banking system on inflation but a negative and statistically significant impact on effectiveness of the monetary policy measured by the inflation gap.
